Group 21:Towards principles for designing inclusive ecological forecasts

Our group is interested in exploring opportunities for improving inclusivity in ecological forecasting. Through discussion, we identified the ten principles of Design Justice (Box. 1) as a potential mechanism for evaluating the inclusivity of forecast products, services, and systems.

1	We use design to sustain, heal, and empower our communities, as well as to seek liberation from exploitative and oppressive systems.
2	We center the voices of those who are directly impacted by the outcomes of the design process.
3	We prioritize design's impact on the community over the intentions of the designer.
4	We view change as emergent from an accountable, accessible, and collaborative process, rather than as a point at the end of a process.
5	We see the role of the designer as a facilitator rather than an expert.
6	We believe that everyone is an expert based on their own lived experience, and that we all have unique and brilliant contributions to bring to a design process.
7	We share design knowledge and tools with our communities.
8	We work towards sustainable, community-led and -controlled outcomes.
9	We work towards non-exploitative solutions that reconnect us to the earth and to each
10	Before seeking new design solutions, we look for what is already working at the community level. We honor and uplift traditional, indigenous, and local knowledge and practices.

As a first step towards applying the Design Justice principles to EFI-created products, services, and systems, our team evaluated to what degree the ten principles were evident in the design of the EFI-NEON Forecast Challenge. We identified several ways in which the design of the Challenge was well-aligned with Design Justice Principles (e.g., Principle 4: We view change as emergent from an accountable, accessible, and collaborative process, rather than as a point at the end of a process.), as well as areas in which we thought we could improve.

Moving forward, we are soliciting broader participation from all EFI community members in small focus groups to continue our internal evaluation of the inclusivity of current EFI products, with the ultimate goal of furthering the inclusivity of ecological forecasting by developing recommendations towards a more complete alignment of EFI-designed products with design justice principles.
