 - i. Could put the ideas on the book club webpage to share with the community and to open it up if there are people who are interested in championing the idea/project we can make it available
 - ii. Jody appreciate's John Zobitz's push during the book clubs to develop something concrete from the discussions. She also appreciates having the opportunity to have a group to read and discuss the books with since she gets more out of the readings that way.
3. EFI Blog Post to Manuscript Ideas
 - a. Check in with Sean about the Design Justice Principles framework for evaluating EFI activities and blog post
 - i. How to use DJP to move toward action. How to assess goals and values (3 boxes from Fig 2) and then connect to Fig 3 and then move to the Table as concrete ways

- ii. Would be good to have an applied version of DJP for EFI.
- iii. Thinking about Sean's timeline - this would be like the introductory material for his greater work

- d. [Service Delivery Framework from NOAA](#) - Chris Brown shared with Jody. The framework provides best practices for decision support products and services and their delivery. Service-oriented approaches, processes, and tools to improve how NOAA's products and services are developed and delivered to society that values user needs. Although this isn't ecological forecasting-specific, Jody thinks this is a good framework to add to our nice framework to point to. See the continuous user engagement figure on pg 5 (Jody added it to the Google slides of figures used during the blog post brainstorm session and pasted the figure below).
 - i. Nick went through all the forecasting papers that had diagrams and compiled them
 - ii. One challenge for Sean when joining EFI is understanding the diagrams
- e. The Translation & Actionable Science working group is working on a set of tutorials about the process of engaging with stakeholders. One thing that came up was thinking about parachute science. Jody wondered if this might be something this group would be interested in helping with or if it was a topic the group would like to discuss on an upcoming call
- f. "Stakeholders" - on a few different calls this term has come up and there has been mentions of people moving away from it because of it's colonial roots. Does anyone know of specific resources related to this?
 - i. Nick has some resources he can share
 - ii. There isn't a good replacement for all the context it is used in, but we can think about how to use it related to forecasting
 - iii. Interested partners/invested partners doesn't quite work

Figure 1. To achieve this vision, NOAA's service providers must (1) continue to build trusted relationships with NOAA's internal and external users and partners; (2) understand the decisions of those users, their use of NOAA information, and be able to gather the user's information needs; (3) evaluate user needs (that cannot be quickly satisfied) through a lens of both NOAA and its partners' capacity; (4) review and prioritize NOAA's products and services to meet the needs; (5) respond to user needs by developing new, or refining existing, products and services across NOAA; (6) deliver these products and services to users; and (7) evaluate user impact of NOAA's tools and services. These elements represent a process. It is imperative that as each element is conducted, interaction occurs between the trusted NOAA entity, end users, and various partners. It is also likely that elements will co-evolve and loop forward, across, and behind in the diagram to verify needs and capabilities, and ensure the provision of the best products and services.
